Also, I'm sure if we reached out to the Civitans and The Ramseur – Eastern Randolph Area Chamber of Commerce they would provide letters of support. It wouldn't hurt to get a letter of support from the Ministerial Association either. I noticed the boy scouts are listed, but I believe we have a new girl scouts chapter forming, you may want to contact them also.

Please take out anything that is not accurate. I know we have been talking about getting the property deeded, but I have not been informed that the deeds have been prepared, executed or recorded. You can say something like we have made agreements with the property owners for these tracts and are currently preparing deeds or agreements to transfer the property

Additionally the "mail box" at the trailhead doesn't seem to be accurate. You may want to say something like usage will be monitored by the Rail Committee while the committee members are walking the trail, the Facebook page and comments on social media.
